### NOTES :

1. **PROXY TO ATTEND AGM ONLY :**

A member is entitled to appoint a proxy to attend and vote at the AGM instead of himself but the appointed proxy need to be a member of the Chamber. The appointment of proxy will be effective only if the letter of appointment of proxy submitted at the registered office of the chamber at least 48 hours before the AGM.

2. **NO PROXY ON VOTING DAY :**

No proxy is allowed to vote on Election day. (At Venue)

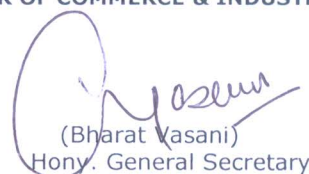

Nomination papers filled in and duly proposed & seconded will be received at Chamber Bhawan Office on Friday, 17<sup>th</sup> to Saturday, 18<sup>th</sup> September, 2021 from 11.00 am to upto 7.00 PM.
3. **Scrutiny of Nomination Papers :**  
Monday, The 20<sup>th</sup> September, 2021.
4. List for valid candidates will be displayed on Notice Board of the Chamber on Monday, The 20<sup>th</sup> September, 2021 from 8.00 pm onwards.
5. **Last date of withdrawal of Nominations :**  
Tuesday the 21<sup>st</sup> September 2021 upto 7.00 pm.
6. List of Contesting Candidates will be put on the Notice Board of the Chamber on Tuesday, 21<sup>st</sup> September, 2021 from 9.00 pm onwards.
7. Remote E.Voting will open on Friday 24<sup>th</sup> September at 10 am upto Sunday, 26<sup>th</sup> September, upto 5.00 pm.
8. 70<sup>th</sup> AGM will be held on Monday, 27<sup>th</sup> September, 2021 at 9.00 am. Venue E.Voting will begin at the Chamber Bhawan from 11.00 am (on completion of the AGM) upto 4.00 pm. (If required election officers can take a call to request the scrutinizer to extend the time).
9. Results will be declared within 2 hours of the end of venue E.Voting.


**IMPORTANT PROVISION FOR ELIGIBILITY TO CONTEST**

1. **EXECUTIVE COMMITTEE (Including Office Bearers)**
  - a) **President & Hony. General Secretary :** Only those candidates will be eligible to contest who had been Office Bearer for at least one term.
  - c) **Vice-President & Hony. Secretary (Industry)** Member should represent any business involving manufacturing activities.
  - d) **Vice-President & Hony. Secretary (Trade & Commerce)** Member should represent business of any Trading/Commerce activities.
  - e) **Vice-President & Hony. Secretary (Taxation & Finance)** Members should carrying profession in Taxation.
2. The representative other than the partner/director/proprietor willing to contest in Chamber Election shall furnish notary affidavit along with the nomination form duly signed by the partner/director/proprietor as the case may be.



3. No Office-Bearer of the Chamber shall hold the same post for the third term consecutively.
4. A person holding any post as Office Bearer or equivalent in any similar organization in Kolhan Division whose name bears resemblance to the name of this organization (such as Chamber of Commerce or alike) shall not be eligible to contest election in this organization for a period of 2 years from the date he/she ceased to hold such post.
5. Members who have completed one year of their membership will only be entitled to be elected as Executive Committee Members.
6. Committee Members including special invitees who have been in the Executive Committee for one term shall only be entitled to be elected as Office Bearer.
7. It is mandatory for all Executive Committee Members to attend minimum of 50% of schedule meetings in a year. However in case of unavoidable circumstances when he/she is not able to attend the meeting if he/she has informed the Chamber in writing before the meeting. In such cases the attendance will be considered in absence subject to maximum 2 (two) in one calendar year.  
Those who have failed to attend the required numbers of meeting shall be debarred from contesting the election for the post of any office-bearer or executive committee member for this term.
8. A candidate contesting for post of Office Bearer shall pay a fees of Rs. 4000/-+ GST 18%= Rs. 4,720/- and for Executive members Rs. 2000/-+ GST 18% = 2,360/- alongwith the nomination paper, as nomination fees. Without payment of nomination fees the nomination shall be treated as invalid. Before filing nomination the candidate should clear his/her dues. Failing which he/she will not be eligible to contest election for any post.
9. A member can file nomination only for one post.
10. Members present personally are only entitled to cast vote. Proxy will not be allowed. Members must carry photo ID at the time of casting of vote.
11. **Member who have cleared their Membership subscription till 17<sup>th</sup> September 2021 shall only be eligible to cast their vote.**
12. Associate Member shall not be entitled to hold any office in the Chamber, nor to stand for election of the committee of the Chamber, nor to nominate/propose anybody for election to the committee.

14. **Duty of Scrutiniser will be performed by CA Jagdish Khandelwal.**
15. **Nomination paper shall be filled in sealed cover, mentioning the name of candidates and post.**
